**What do the Board Members Do?**

As volunteer representatives of the membership of KRD Federal Credit Union, Board Members review the financial condition of the credit union, make decisions on the direction of the credit union and set the vision for the future of KRD Federal Credit Union. Volunteers must be able to attend a monthly meeting. Generally, Board Members will need to dedicate about two (2) hours a month to conduct KRD Federal Credit Union business.

**What Does the Supervisory Committee Do?**

KRD Federal Credit Union's Supervisory Committee ensures the financial well-being of the credit union as well as the prompt preparation of accounting records and reports. This committee acts as the members' "watchdog" and makes certain the credit union maintains it's standard of excellence and that all regulations, procedures and policies governing KRD Federal Credit Union are followed. Generally, Supervisory Committee member will need to dedicate about one (1) hours a month to conduct KRD Federal Credit Union business.

**Who Can Volunteer?**

Any Primary adult member in good standing is eligible to for a three-year term on the Board of Directors or as a Supervisory Committee member.
